Builders Exchange of Dayton Membership Credit Card Billing Policy

Initiation of Recurring Payment Option

Builders Exchange of Dayton offers automatic billing directly to a member's credit card. A member may exercise the recurring payment option by completing the BX of Dayton Authorization for Credit Card Billing form and returning it to the BX of Dayton. Upon receipt of the authorization, payments will be charged to your card beginning with the current month. Each month (or quarter depending on your selected frequency), BX of Dayton will charge your credit card with the current dues charge.

Changing Recurring Payment Option

If you would like to change your Credit Card Payment Option including, for example, making a change from one credit card to another, you must authorize the recurring payment with the new credit card by completing a new form. The change will not go into effect until the billing cycle after the new form is received. Your previously approved credit card payment option will be used until the new option goes into effect.

Recurring Payment Failure

If your recurring payment is declined, your monthly credit card payment option will be removed and the BX of Dayton will invoice you for the remaining portion of your annual dues and/or services payable in full upon receipt. If payment is declined by your credit card company, this does not relieve you of your contractual responsibilities. The BX of Dayton will pursue full payment up to and including legal action. If your company fails to remit payment, you may be considered in financial arrears and access may be denied to BX of Dayton member programs as well as to any on-line service until your account is current. No credit will be issued for lost-time access to BX of Dayton programs and services.

Cancellation of Recurring Payment Option

Credit card payment option agreements are effective for no fewer than 12 months. If after the first 12 months of enrollment you wish to discontinue your recurring credit card payment option, you must submit your written cancellation notice and allow 30 days for processing.
