#### **OSHA Activities and Enforcement:** Avoid the Penalties

#### **Electronic Filing**

In May we reported a change by the Occupational Safety and Health Review Commission (OSHRC) concerning the electronic filing on Notices of Contest. The notice from the OSHRC made it appear that all Notices of Contest filed after June 10, 2019 would have to be filed electronically if the employer or the employer's representative had already established itself under the electronic filing procedures of the OSHRC. At first I hesitated to bring this to our members attention because in the forty plus years I have been counseling and representing employers in OSHA and workplace safety matters it has been clear that the OSHRC does not have jurisdiction of a case until after the Notice of Contest has been filed. However, so as to be sure that our members and my other clients made timely filings of their Notices of Contest, I advised that they continue to mail the Notice of Contest (NOC) to the Area Director who issued the citations, but also electronically file the NOC with the OSHRC if they had established an electronic filing profile with the OSHRC. In this way, the employer would make sure it effectively filed its NOC. Recently, after more digging, we have determined that the NOC does not have to be electronically filed with the OSHRC to be effective. As I felt at the outset, the OSHRC does not get jurisdiction of an NOC until after the Area Director has forwarded the NOC to the Solicitor for the Department of Labor and the OSHRC. So, we can all go back to the past practice we employed to file an NOC. Electronic filing will come into play now on all contested cases.

#### **Safety Enforcement**

If any of you have heard me speak on safety and OSHA compliance, you have heard me say, "Enforcement of your safety rules is essential to demonstrating that you have an effective safety culture and that safety is a cornerstone of your business." I have repeated these same comments to those of you who have participated in our ELITE Safety Recognition Program. As I continue to get involved in one way or another with the defense of OSHA citations received by my clients, I am finding that many of you are still giving "lip service" to safety enforcement. While you continue to take a very "soft approach to safety enforcement, OSHA is stepping up enforcement activities and increasing the amount of the fines and penalties they are levying against companies for safety and health violations. Recently Fuyao, an auto glass manufacturer in my own backyard, Dayton, Ohio, was fined \$724,389 for "exposing employees to multiple safety and health hazards". There were certainly reasons for the number of citations and the amount of the fines. Having said that, I would also like to point out that the Acting Regional Director of OSHA'S Region V, which is headquartered in Chicago, went further to drill in on the responsibility of employers to make sure their employees understand ALL safety rules and comply with them. Bill Donovan, the Acting Regional Administrator stated that "This company's repeated failure to implement and enforce safety and health programs at the workplace is unacceptable. Employers must continually evaluate their facilities for hazards, and train employees and managers to use proper safety controls and equipment to keep their worksites safe and healthful." When you couple this with the language used by OSHA on October 11, 2018 when it slightly relaxed the existing prohibitions against mandatory post-accident drug testing and rate based incentive programs, you can clearly see that OSHA believes a strong safety culture with an employer is evidenced by effective training and consistent and objective enforcement of safety rules. I think Mr. Donovan's comments send a clear message to employers in Region V that OSHA will be looking at training and safety enforcement when it considers how to effectively deal with an employer following an inspection during which safety compliance violations were noted.

Having said all I did in the preceding paragraph, I want to remind you that my comments in this article and others I have written, and will write in the future, are focused on employee safety, not on avoiding citations and/or keeping fines and penalties low. However, having an effective enforcement program in your company is essential to defeating citations based on unpreventable employee misconduct and demonstrating your commitment to safety to regulatory authorities. Having interviewed many employees in various industries in the past forty plus years, I can assure you that if you only orient your OSHA is stepping up enforcement activities and increasing the amount of the fines and penalties they are levying against companies for safety and health violations."

employees on your safety rules when they are hired and perform weekly toolbox talks and nothing more, you could randomly select twenty-five percent of your employees on any job site and interview them and, in most cases, fewer than fifty percent of them would be able to correctly respond to ten questions about your safety program and rules. I am pretty sure that with many, if not most of you, if I were to take a look at your safety enforcement program (presuming you have one) I would find inconsistent enforcement at best. Remember to be complete. Your enforcement program must contain retraining along with any disciplinary action.

#### **Regulatory Activity**

I have two items to report concerning regulatory activity. First, H.R. 3668 has been introduced in the House by Representative Judy Chu of California. This bill is titled the Asuncion Valdivia Heat Stress and Fatality Prevention Act of 2019. The bill, if it becomes law, will require OSHA to promulgate a final rule within two years of the Bill's enactment. The Bill would require employers to develop procedures and methods for initial and regular monitoring of employee exposure to assess whether they are exposed to excessive heat. Beyond this, the Bill has requirements that mirror the 2012 NIOSH criteria document on heat illness prevention, although it does provide a requirement for hazard prevention, including engineering controls, administrative controls, or PPE. The Bill is named after a California farm worker who died from heat stroke in 2004. As I have advised in the past, it

was only going to be a matter of time before OSHA would move to promulgate a rule to address the heat stress issue. Apparently, OSHA was not moving fast enough for Congress. In addition to the 130 organizations which have signed on to a petition to OSHA to move on this issue, climate change has also been drawn into the mix. While I hesitate to predict what will happen to this bill, heat illness is a topic with a high level of interest. The bill sends a message that at least one member of Congress does not feel that OSHA is moving quickly enough to address this problem. So, i think we can assume that the issue is now going to move forward, either at the Congressional level or through OSHA rule making.

Finally, on July 29th OSHA submitted a draft notice of a Request For Information (RFI) preparatory to the Office of Management and the Budget (OMB). The RFI, when it is published in the Federal Register, will seek information regarding tasks and tools that are listed in Table I of the current Respirable Crystalline Silica Standard. The goal is to provide additional common construction industry tasks with corresponding dust control methods to ease some of the burden on the construction industry in addressing this material. Stay tuned for more information as it becomes available.

# **A CENTURY OF ROOFING**

maha's oldest roofing contractor's story started with Independent Roofing Company founder, Arthur Kersawe in 1919. In the beginning, IRC focused primarily on residential roofing. he Internal Revenue Service issued a draft of the 2020 Form W-4, Employee's Withholding Allowance Certificate that will make accurate withholding easier for employees starting next year.

The revised form implements changes made following the 2017 Tax Cuts and Jobs Act, which made major revisions affecting taxpayer withholding. The redesigned Form W-4 no longer uses the concept of withholding allowances, which was previously tied to the amount of the personal exemption. Due to changes in the law, personal exemptions are currently not a central feature of the tax code.

"The new draft Form W-4 reflects important feedback from the payroll community and others in the tax community," said IRS Commissioner Chuck Rettig. "The primary goals of the new design are to provide simplicity, accuracy and privacy for employees while minimizing burden for employers and payroll processors."

The IRS and Treasury collected extensive feedback over the past year while working closely with the payroll and tax community to develop a redesign that best serves taxpayers.

The IRS released a near-final draft of the 2020 W-4 in July to give employers and payroll processors the tools

they need to update systems before the final version of the form is released in November

The IRS reminds taxpayers that this draft W-4 is not for current use, but is a draft of the form to be used starting in 2020. Employees who have submitted a Form W-4 in any year before 2020 will not be required to submit a new form merely because of the redesign. Employers can continue to compute withholding based on the information from the employee's most recently submitted Form W-4.

For 2019, taxpayers should continue using the current W-4. The IRS also continues to encourage people to do a Paycheck Checkup as soon as possible to see if they are withholding the right amount of tax from their paychecks, particularly if they had too much or too little tax withheld when they filed their 2018 taxes earlier this year. People with major life changes, such as a marriage or a new child, should also check their withholding.

The IRS cannot respond individually to those who submit comments, but the agency does appreciate the feedback and will consider all comments received.

#### FAQs on the Early Release of the 2020 Form W-4

1. Why redesign Form W-4? The new design reduces

the form's complexity and increases the transparency and accuracy of the withholding system. While it uses the same underlying information as the old design, it replaces complicated worksheets with more straightforward questions that make accurate withholding easier for employees.

- 2. What happened to withholding allowances? Allowances are no longer used for the redesigned Form W-4 to increase transparency, simplicity, and accuracy. In the past, the value of a withholding allowance was tied to the amount of the personal exemption. Due to changes in law, currently you cannot claim personal exemptions or dependency exemptions.
- Are all employees required to submit a new Form W-4? No. Employees who have submitted Form W-4 in any year before 2020 are not required to submit a new form merely because of the redesign. Employers will continue to compute withholding based on the information from the employee's most recently submitted Form W-4.

#### **Employee FAQs**

- 4. My tax situation is simple. Are some questions optional? Yes. The form is divided into 5 steps. The only two steps required for all employees are Step 1, where you enter personal information like your name and filing status, and Step 5, where you sign the form. If Steps 2 4 apply to you, your withholding will more accurately match your tax liability if you complete them.
- 5. What happens if I only fill out step 1 and then sign the form? Your withholding will be computed based on your filing status's standard deduction and tax rates, with no other adjustments.
- 6. When should I increase my withholding? You should increase your withholding if 1) you hold more than one job at a time or you and your spouse both have jobs (Step 2) or 2) you have income from sources other than jobs that is not subject to withholding (line 4a). If you do not make these adjustments, you will likely owe additional tax when filing your tax return, and you may owe interest and penalties. With regard to income from other sources, you can pay estimated tax instead of having extra withholding.
- 7. When should I decrease my withholding? If you are eligible for income tax credits such as the child tax credit or credit for other dependents, and/or you are eligible for deductions (other than the standard deduction), you can follow the instructions described in lines 3 and 4b to decrease your withholdings by the appropriate amount.
- 8. I want a refund when I file my tax return. How should I complete the redesigned Form W-4? The redesigned Form W-4 makes it easier for you to have your withholding match your tax liability. But some

employees may prefer to have more of their money withheld from their paychecks throughout the year and then get that money back as a refund when they file their tax returns. The simplest way to increase your withholding is to enter on line 4c the additional amount you would like your employer to withhold from each paycheck after your Form W-4 takes effect. Whether you will be due a refund (and, if so, the amount of your refund) when you file your tax return depends on the details of your entire tax situation.

- 9. Why do I need to account for multiple jobs (Step 2)? I have never done that before. Tax rates increase as income rises, and only one standard deduction can be claimed on each tax return, regardless of the number of jobs in the household. Therefore, if you have more than one job at a time or are married filing jointly and both you and your spouse work, more money should usually be withheld from the combined pay for all the jobs than would be withheld if each job was considered by itself. Adjustments to your withholding usually should be made to avoid owing additional tax, and potentially penalties and interest, when you file your tax return. All of this has been true for many years; it did not change with the recent tax law changes. The old Form W-4 accounted for multiple jobs using detailed instructions and worksheets that many employees may have overlooked. Step 2 of the redesigned Form W-4 lists three different options you may choose from to make the necessary withholding adjustments.
- 10. Which option in Step 2 should I use to account for my multiple jobs? Which is most accurate? What if I don't want to reveal to my employer on my W-4 that I have a second job?

**Step 2** allows you to choose one of three options, which involve tradeoffs between accuracy, privacy, and ease of use:

**Option 1:** For maximum accuracy and privacy (to avoid revealing to your employer on your W-4 that you have multiple jobs) use the calculator at www.irs.gov/W4app. You will be guided to enter an additional amount to withhold on line 4c. You will need to know the approximate amount of pay for each job, but you will need to enter the additional amount on the Form W-4 for only one of the jobs. If pay for any of the jobs changes significantly, you will need to furnish a new Form W-4 to have accurate withholding.

**Option 2:** If you do not have access to the online calculator but wish to have roughly accurate withholding while retaining privacy, you may use Worksheet 1 on page 3 and similarly be guided to enter an additional amount to withhold on line 4c. You will need to know the approximate amount of pay for each job, but you will need to enter the additional amount on the Form W-4 for only one of the jobs. If pay for any of the jobs changes the additional withholding amount in the lookup table, you will need to

furnish a new Form W-4 to have accurate withholding.

Option 3: If there are only two jobs held at the same time in your household, you may check the box in Step 2 on the forms for both jobs. The standard deduction and tax brackets will be divided equally between the two jobs. You would not need to furnish a new Form W-4 to account for pay changes at either job. This option is less accurate—more tax than necessary may be withheld from your wages—but you generally won't have too little tax withheld. (The more similar the earnings at the two jobs, the more accurate this option will be. To get an idea of how much overwithholding you can expect in your case, see the tables that will be provided in the 2020 Pub. 505.) This option reveals to your employer on your W-4 that you have multiple jobs in your household. But it also is the easiest option to use: just check the box.

11. The instructions above Step 3 say that in multiple job households, adjustments in lines 3 through 4b are to be made on only one form, and that withholding will be most accurate if the adjustments are made on the W-4 for the highest paying job. But what happens if pay at two jobs is relatively similar or if the job that pays more changes over time? In general, making these adjustments on the Form W-4 for the highest paying job increases accuracy. However, if the jobs in your household pay about the same or if the job that pays more changes over time, it is less important which Form W-4 is used to make the adjustment.

- 12. What if I have a side gig where I'm not treated as an employee? If you have self-employment income, you will generally owe both income tax and self-employment tax. Form W-4 is primarily intended to be used by employees who are not subject to self-employment tax. Thus, like the old Form W-4, the redesigned Form W-4 does not compute self-employment tax. If you would like to use Form W-4 to make an adjustment to your withholding to account for self-employment income that you will receive from another source, use the withholding calculator at www.irs.gov/W4app or refer to IRS Publication 505.
- 13. What if I don't want to reveal my non-job income, such as income from earnings on investments or retirement income, to my employer (line 4a)? You are not required to have tax on non-wage income withheld from your paycheck. Instead, you can pay estimated tax on this income using Form 1040-ES, Estimated Tax for Individuals. However, if you want to use Form W-4 to have tax for this income withheld from your paycheck, you have two options. You can report the income on line 4a. If you don't want to report this income directly on line 4a, you can use the withholding calculator at www.irs.gov/W4app. The calculator will help you calculate the additional amount

of tax that should be withheld from your paycheck. You will then enter that amount on line 4c, without reporting the income to your employer. If you expect to have dividend or capital gain income, your withholding will be more accurate if you have the calculator compute the withholding adjustment rather than reporting this income on line 4a.

14. I have a more complex tax situation. Is there a computer program I can use to help me complete Form W-4? Yes. To provide maximum accuracy, you are encouraged to use the withholding calculator available at www.irs.gov/W4app. Updates and improvements to the calculator are underway that will be compatible with the redesigned Form W-4 in 2020. You may wish to use the withholding calculator if you 1) expect to work only part of the year, 2) have dividend or capital gain income or are subject to additional taxes, such as the net investment income tax, 3) have self-employment income, 4) prefer the most accurate withholding for multiple job situations, or 5) prefer to limit information provided in Steps 2–4 but do not want to sacrifice accuracy.

#### **Employer FAQs**

- 15. Does this mean our software will need two systems—one for forms submitted before 2020 and another for forms submitted after 2019? Not necessarily. The same set of withholding tables will be used for both sets of forms. You can apply these tables separately to systems for new and old forms. Or, rather than having two separate systems, you may prefer to use a single system based on the redesigned form. To do this, you could enter zero or leave blank information for old forms for the data fields that capture the information on the redesigned form but was not provided to you under the old design. Additional guidance will be provided on the payroll calculations needed based on the data fields on the new and old forms.
- 16. How do I treat employees hired after 2019 who do not submit a Form W-4? New employees who fail to submit a Form W-4 after 2019 will be treated as a single filer with no other adjustments. This means that a single filer's standard deduction with no other entries will be taken into account in determining withholding. The IRS and the Treasury Department anticipate issuing guidance consistent with this approach.
- **17.** Are employees hired after 2019 required to use the redesigned form? Yes. Beginning in 2020, all new employees must use the redesigned form. Similarly, any employees hired prior to 2020 who wish to adjust their withholding must use the redesigned form.
- 18. What about employees hired prior to 2020 who want to adjust withholding from their pay dated

January 1, 2020, or later? Employees must use the redesigned form.

- **19.** May I ask all of my employees hired before 2020 to submit new Forms W-4 using the redesigned version of the form? Yes. You may ask, but as part of the request you should explain that (1) they are not required to submit new Form W-4 and (2) if they do not submit a new Form W-4, withholding will continue based on a valid form previously submitted. For those employees who furnished forms before 2020 and who do not furnish a new one after 2019, you must continue to withhold based on the forms previously submitted. You are not permitted to treat employees as failing to furnish Forms W-4 if they don't furnish a new Form W-4. Note that special rules apply to Forms W-4 claiming exemption from withholding.
- 20. Will there still be an adjustment for nonresident aliens? Yes. The IRS will provide instructions in the 2020 Publication 15-T Federal Income Tax Withholding Methods on the additional amounts that should be added to wages to determine withholding for nonresident aliens. Additionally, nonresident alien employees should continue to follow the special instructions in Notice 1392 when completing their Forms W-4.

ave you ever been fitted for a custom-made suit? Made-toorder, perfectly fitted, tailoredmade suit just for YOU!? It is often a long process; starting with identifying the suit's purpose (wedding, business,

special occasion), then budget, next choosing of fabrics, followed by measurements and fittings, accessories, etc... the list goes on! It can be a lengthy process but the results are noticeably pleasing and worth all the time and work.

The University of Cincinnati has one of the most architecturally diverse campuses in the United States and home to the iconic Albert H. Vontz Center for Molecular Studies. The building is nearing 20 years and is in need of a new roof, or should I say, a new TAILOR-MADE roof?! Just by looking at the exterior of the building, one can see that no wall is the same, no angle repeated, no measurement alike. Now imagine yourself on top of this building, where there are multiple roof areas, all with different slopes, pitches, and details along with those funky curved walls you see from the ground that make the parapet walls of the roof system. Logistically, this job faced many difficulties. With this building being in the heart of the UC main and medical campuses, surrounding streets and sidewalks needed to remain accessible for emergency vehicles, medical staff, students, other trades, etc... Project planning, crane lift schedules, mobilization charts, site specific safety plans, etc... are just a piece of this project's puzzle.

Access to the roof was the next piece of the puzzle, and the Vontz Center proved this to be one of the more difficult tasks. The surrounding landscape made stair tower set up almost impossible. The stair tower seen in the above picture barely fit between the bending walls of the MLK street-facing side of the building. Two more stair towers are located on the back side of the building, granting access to other roof areas that are otherwise not accessible via rooftop.

A 70-ton crane was used to assist in the disposing of 9 different roofs, made up of approximately 3" of insulation, EPDM membrane, and a pavered ballast system. All with different safety plans, interior sensitivities, roof access, surrounding landscapes, but only ONE granted dumpster location. Nearly 30 dumpsters and 20 different crane visits

were used to execute these tear offs and set ups. This job is still ongoing.

As stated before, each roof area has its own unique access and characteristics - all carefully measured and fitted for material ordering specific to that roof area.

Nearly 600 pieces of galvanized steel metal coping, each custom measured and fabricated in-house and delivered to the job upon request for installation, fitting to the existing parapet like a puzzle piece, each in its specific place. One roof area may be in the metal or roof install phase, while another roof area is still in the tear off phase. All going simultaneously. At times, 3 roofing crews and 2 metal crews were all on the job, all undergoing different phases of the project.

Overseeing the job, Erik Kramer, Roofing Superintendent and Vice President, runs the everyday operations of the

crews. From organizing crane lifts to overseeing details and quality control in the field, Erik is equip with the knowledge and experience to oversee a complex project like this. Every day brings a new challenge. Erik has spent most every day on the job, working side by side the general contractor, owner, and crews alike, keeping the project moving, addressing any issues as they arise and finding solutions along the way.

As much as we would like to foresee and plan for everything, a job like this can often bring unknown and unexpected truths about the building and or roof. It takes a flexible, experienced, and talented team to adjust to the needs of the building and customer for a project like this to be successful.
